### **Composition of CSR Committee**

Our Company is a Private Limited Company and hence not require to appoint an independent director pursuant to sub-section (4) of section 149 of the Act, and shall have its CSR Committee without such director. Therefore we will constitute committee with Mr. Shishir Rambhau Gorle and Mr. Raja Sekhar Reddy, Directors of the Company.

### **Role of the Committee:**

The Committee shall carry out of the following functions:

### **Quantum of Amount to be spent on CSR Activities**

The Company shall strive to spend in every financial year at least 2% (two percent) of the average net profits of the Company made during the three immediately preceding financial years. However budget of the CSR activities will also be driven by the requirement of various CSR projects.

Our Corporate Social Responsibility policy conforms to the provisions under Section 135 of the Companies Act, 2013 and Corporate Social Responsibility Rules, 2014 as well as activities as stated in Schedule VII of the Companies Act, 2013.
