The following Notification will be published in the next Issue of the Telangana State Gazette:

NOTIFICATION

Whereas, the Government of Telangana, in G.O.Rt.No.163, Labour Employment Training and Factories (Labour) Department, Dated: 23.02.2016 has declared the Motor Transport Industry in the Telangana as a Public Utility Service for the purpose of Industrial Dispute Act, 1947 (Central Act 14 of 1947) for a period of six months with effect from 23.02.2016.

2. Whereas the said period of six months has already been expired on 22.08.2016.

3. And whereas, the Government of Telangana, is satisfied that it is necessary to declare the said industry as Public Utility Service for a further period of six months in public interest.

4. Now therefore, in exercise of the powers conferred by sub clause (VI) of clause (n) of Section 2 of the Industrial Dispute Act, 1947 (Central Act 14 of 1947), Government of Telangana hereby declares the Motor Transport Industry in the State of Telangana as a Public Utility Service Unit for a further period of six months with effect from 23.08.2016, since the industry specified in 1st schedule of Industrial Dispute Act, 1947.
