In exercise of the power conferred by Sub-section 2 of Section 9 of the West Bengal Labour Welfare Fund (Amendment) Act 2017 (West Bengal Act XLVI of 2017), the Government of West Bengal, by an order published in Gazette Nos. i. Labr./606/(LC-LW) LW/6L-05/03 dated 28/08/2018 and ii. Labr./607/(LC-LW) LW/6L-05/03 dated 28/08/2018 has revised the rate of contribution for every six month in the following manner with effect from 1st September, 2018:

<u>Sl. No</u>	<u>Category</u>	<u>Previous Rate of Contribution</u>	<u>Revised Rate of Contribution</u>
1.	Employees'	Rs.3/- per head per half year	Rs.3/- per head per half year
2.	Employers'	Rs.6/- per employee per half year	Rs.15/- per employee per half year

Any default in respect of deposit of the statutory dues is punishable with imprisonment which may be extended upto one year or fine upto Rupees two thousand only or both.

In exercise of the power conferred by sub-section 2 of Section 9 of the Labour Welfare Fund Act, 1974 (as amended), the Governor is pleased hereby to fix the following rates of contribution for each employee whose name stands on the register of an establishment:

- a) The employer's contribution shall be fifteen rupees, and
- b) The employees contribution shall be three rupees.

Such contributions shall be payable every six months ending on the thirtieth day of June and the thirty first December each year.
